^^ From 1 Jan 2014, Associate Members must be companies with S.88 or statutory status, or companies by invitation of BoD on case-by-case basis. To avoid confusion with the term in BEC M&A, after approval in BoD meeting on 11 Feb 2014, "Affiliate Member" will be the name for this class of membership.

Annual Membership Fee is collected immediately upon joining or upon renewal.

With BoD approval, free Affiliate membership may be granted.
