The environmental impacts of the goods, materials and services you buy or source can be just as substantial or even more so than the direct impacts of your business.

Toxic dyes used in textiles, poor agricultural standards for food, conflict minerals in electronics, and the deforestation impacts of timber and palm oil have major impacts and are all major reputational issues. GRI and CDP ask for reporting on supply chains.

This 3-hour course designed for managers explains how to integrate good sustainable procurement and supply chain management into your organisation and processes. It takes you through the forthcoming ISO 20400, as well as setting out how to embed sustainable procurement in procurement & supply chain processes in a straightforward and cost-effective manner.
