SUMMER MEET-UP WITH THE ENVIRONMENT BUREAU

BEC Board of Directors met with **Under Secretary for the Environment, Mr CW Tse**, and **Permanent Secretary for the Environment, Ms Maisie Cheng**, on 26 June 2019 for a fruitful dialogue on BEC's policy recommendations to the Government under the three areas of climate change and decarbonisation, resource management and circular economy, and sustainable living environment. Views exchanged at this engaging meeting will feed into BEC's written submission of policy recommendations on the Chief Executive's 2019 Policy Address. The draft will be circulated to BEC members for inputs in July before submitting to the government by the end of August.



BEC Policy Dialogue Series: Long-term Decarbonisation Strategy



50+ participants joined this BEC members' only event on 27 June 2019, meeting with **Mr Lam Chiu-ying**, Convenor of Support Group on Long-term Decarbonisation Strategy for the Council for Sustainable Development, plus **Dr Winnie Law**, and **Mr Darwin Leung** from The University of Hong Kong with regard to the government's recently launched public engagement on Hong Kong's long-term decarbonisation strategy. This highly informative event gave our members a better understanding on the government's strategy and public engagement process as well as an opportunity for fruitful interaction with the speakers. Views and ideas will be consolidated into a policy submission which will be circulated to BEC members for further inputs later on.

The Low Carbon Hong Kong Initiative: Two New Executive Briefings Published

The BEC Low Carbon Charter, launched on 19 March 2019, mobilised more than 30 major companies across Hong Kong's property and construction value chain to commit to set and achieve ambitious decarbonisation targets in working towards a sustainable and low carbon future. Now that the commitments have been made, the challenge of following through and implementing the commitments begins.

To support signatories' advance in their decarbonisation journeys, BEC published two Executive Briefings: **"Setting Robust Decarbonisation Targets for Business"** and **"Achieving Significant Decarbonisation in the Property and Construction Sector"** which walk readers through how to set targets and achieve decarbonisation. Also, workshops will be held as part of the programme to support signatories. The first workshop, **"Stepping up to the BEC Low Carbon Charter: How to Set and Achieve Decarbonisation Targets"** was held on 21 June 2019 featuring presentations from industry experts including representatives from BEC's advisory teams, as well as experience and best practice sharing from peers. The event was attended by 60+ delegates. The second workshop will be organised later this year. Stay tuned!

The company also aims to bring appropriate charging infrastructure to all its workplaces by 2030 to support the staff who rely on car transport for commuting to switch to EVs.

BEC Council Member **The Kowloon Motor Bus Co. (1933) Limited** received the Gold Award in the Transport and

Logistics Sector of the 2018 Hong Kong Awards for Environmental Excellence for its advanced green technologies and innovative ideas. A highlight is their in-house developed double-deck buses equipped with solar panels that provide speedy cooling and fuel saving. Solar panels are being installed on 600 bus stop rooftops and bus stop poles are equipped with solar power system, which can automatically light up in the dark for passengers to read route information. The company has close to 3,000 Euro V/Euro VI standard buses, including 10 battery-electric buses and eight supercapacitor buses, and 20 electric cars for patrolling and back-up duties. Sharing of resources is also achieved through their Donation of Used and Retired Bus Programme which donates retired buses to primary and secondary schools for educational use.

Following the consultation paper on "Review of the Environmental, Social and Governance (ESG) Reporting Guide" by Hong Kong Exchanges and Clearing Limited in May, Allied Sustainability and

Environmental Consultants Group Limited, the holding company of BEC Corporate Member **Allied Environmental Consultants Limited**, co-hosted a briefing with the Chamber of Hong Kong Listed Companies and ProSage Sustainability Development Limited in June. Representatives of listed companies from diverse industries attended the session to learn more about the proposed changes to the ESG Reporting Guide, such as "comply or explain" provisions that require companies to disclose climate change-related risks and targets set for environmental key performance indicators. Participants also acquired practical knowledge of the impact and challenges that these requirements might bring about.

BEC Corporate Member, the **Fung Group**, partnered with a NGO on a less plastic campaign in May. 300+ colleagues from across the group pledged to avoid using single-use plastic on 30 May 2019 and shared photos on Li & Fung's One Family communication platform and social media to show their creative and sustainable actions. Surveys conducted before and after the campaign indicated participants had adopted good practices such as using reusable containers, avoiding plastic bottled beverages and pre-packed items, etc. Circle K and St Honore Bakery, companies under Fung Group, supported the campaign by offering discounts to customers for bringing their own reusable containers. LF Logistics hosted a Lunch and Learn session with speakers from this NGO and the Group's recycler to share ideas on taking progressive action to reduce single-use plastic both in the office and the staff's daily life.

is committed to providing their 2,400+ staff, and thousands of tenants and visitors with healthy and environmentally friendly workplace. The company continues to improve the indoor air quality of SuperTerminal 1, receiving Excellent Class (Whole Building) for both office blocks from the IAQ Certification Scheme. Their South Office Block, which is frequently used by tenants, was successfully upgraded from Good to Excellent Class. This accolade demonstrates the company's efforts in promoting the well-being of their staff and terminal users.

BEC Corporate Member **Hong Kong Aircraft Engineering Company Limited**

collaborates with its clients to use "aircraft dry wash" technique to clean their aircrafts. In contrast to traditional methods which typically needs thousands litres of water per wash, the new technology requires little or no water in cleaning the aircrafts. With the application of environmentally friendly detergent, aircrafts can save jet fuel by avoiding towing for long distance. Also, the anti-dirtying and anti-static functions of the detergent prevent adhesion of dirt on aircraft surfaces, resulting in less drag during flight and reduced frequency of wash. It is estimated that the dry wash process can save 90% of water when compared with traditional methods and 189 tonnes of CO₂ per year from less towing.

Come along and join our upcoming BEC Industry Visit to O-PARK1, a self-sustained organic resources recovery centre in Hong Kong. With 200 tonnes of daily treatment capacity, O-PARK1 adopts advanced anaerobic digestion and composting technologies to convert food waste into biogas for power generation. Apart from generating heat and power for internal use, it is estimated that the site can generate about 14 million kWh of surplus electricity, an equivalent of 3,000-household energy consumption.
