Submission on the Chief Executive's 2019 Policy Address



BEC has submitted our views for the Chief Executive's 2019 Policy Address, with policy recommendations aligned with BEC's three new environmental focus areas: Climate Change, Circular Economy, and Sustainable Living Environment.

In the submission, we stressed the importance of supporting businesses in their decarbonisation journey, developing a circular economy policy roadmap, managing transport demand with a goal to reduce emissions and improve liveability, and facilitating policy development to incorporate the United Nation's Sustainable Development Goals.


BEC Anniversary Dinner 2019

BEC Low Carbon Charter



The BEC Low Carbon Charter mobilises companies to step up and take positive climate action towards the goals of the Paris Agreement, beginning with the property & construction sector. There are currently 33 signatory companies: 29 companies committing to Pathway 1 and 4 companies committing to Pathway 2.

BEC is pleased to announce that all 4 of our Pathway 2 signatories have officially joined and are listed by the Science Based Targets initiative (SBTi), fulfilling a significant part of their Pathway 2 commitments. Officially committing to SBTi means that the companies will work to set science-based emissions reduction targets and will have the targets independently verified against the SBTi criteria. 
