Submission on the Public Consultation for the 2025-2026 Budget

This initiative offers a unique opportunity for businesses dedicated to promoting sustainable packaging, reducing packaging waste, and contributing to Hong Kong's long-term carbon reduction goals.

By joining the Packaging Reduction Charter, your business will align with the government's vision of achieving Zero Landfill, while positioning your company as a leader in sustainability. As a signatory, your company can enjoy several key benefits:

- 1. **Enhanced Corporate Image** Receive a Certificate of Commendation from the EPD, recognising your commitment to packaging reduction;
- 2. Professional Support Access EPD's expertise and resources on packaging reduction and recycling initiatives; and
- 3. **Packaging Reporting Support** Listed companies and their supply chains will receive support in preparing packaging-related data for t ESG reports, including Scope 3 emission disclosure, as required by the HKEX.

Organisations are encouraged to submit their Application Form as soon as possible to ensure ample time for processing. Participating organisations will be invited to the launching ceremony on 31 March 2025, officiated by the Secretary for Environment and Ecology. Participants will receive a certificate from EPD and have the opportunity to take group photos with government officials. Submit your Charter application here!

Council Members

Airport Authority Hong Kong ("AAHK") has been recognised as a Top-Rated ESG Performer by a leading global ESG rating firm for the third consecutive year. AAHK has maintained an overall "Low Risk" ESG rating, landing in the top three percentile of the "Airports" sub-industry category and ranking among the top three out of 84 evaluated airports. This recognition reflects AAHK's proactive approach to managing ESG risks and its commitment to a comprehensive risk management framework designed to identify and mitigate sustainability-related risks. AAHK demonstrated strong performance in areas such as stakeholder governance, community relations, emissions, effluents and waste.



CLP Power Hong Kong Limited and fellow BEC Member City University of Hong Kong co-organised an international conference titled "Powering a Carbon Neutral Future -The Role of Nuclear Energy" on 17 January, exploring the pivotal role of nuclear energy in the decarbonisation journeys of Hong Kong, Mainland China, and the world. The conference brought together over 20 renowned scholars and energy experts from Hong Kong, Mainland China, the United Kingdom and France to discuss issues on climate change and sustainability, highlighting Hong Kong's role as a "super-connector" and "super value-adder" between Mainland China and the rest of the world. China State Construction Engineering (Hong Kong) Limited ("CSHK") has recently introduced its Solar-Powered Rest Station developed by a local technology company, emphasising workers' welfare and climate resilience. Strategically placed around construction sites, this eco-friendly station provides a comfortable resting space for construction workers, equipped with essential amenities like drinking water and airconditioning to ensure hydration and cooling in hot weather. The Rest Station features solar panels and lithium iron phosphate batteries, accommodating four to six workers in a 70-square-foot space. The photovoltaic panels convert solar energy into electricity for air conditioners, ventilation fans, lighting, and power outlets. In low sunlight, it can connect to the grid or generators for uninterrupted operation. Outperforming similar products, it offers an extended eight-hour operation period. CSHK remains dedicated to achieving comprehensive sustainability through continuous innovation, driving green construction practices and enhancing worker welfare.



Hang Lung Properties sets out to advance sustainability in real estate through its cross-sector partnership with a university in Beijing. This endeavour led to the establishment of The Hang Lung Center for Real Estate at the university, driving innovative research for industry growth. The recent Sustainability in Real Estate Conference, hosted by the Center, gathered over 3,000 participants to explore real-world solutions to industry challenges. Spotlighting ten research projects on climate resilience and resource management, the event facilitated knowledge exchange and empowered the real estate sector to effectively adopt sustainable strategies, paving the way for a greener future in real estate.



Henderson Land continues its passion to inspire the next generation by sharing insights on its sustainability vision and strategy, welcoming students from a local university for a tour of The Henderson. The students engaged with innovative architecture and explored ESG features of The Henderson. The company is pleased to witness the students' enthusiasm, keen interest and inquisitiveness, and hope to provide them with valuable knowledge as well as spark inspiration in sustainable architecture and urban development.



Nine restaurants in **Nan Fung Group**'s flagship shopping mall AIRSIDE have joined the AIRSIDE Circular Programme since its launch in April 2024, an initiative focused on reducing single-use plastics, enhancing the company's sustainability efforts. Customers of the mall can borrow reusable cups and containers for free via the NF Touch app, enjoy a HK\$3 discount on takeaway items, and earn 50 NF Seeds with each purchase. These seeds can be shared with NGO partners, which will be converted into acts of kindness for those in need.



Swire Pacific has recently been honoured with multiple prestigious ESG awards, highlighting its commitment to best practices in ESG. The accolades include the Green Low-Carbon Pioneers Award from the KPMG ESG 50 Awards 2024, Excellence Award in Environmental, Social and Governance Reporting at the Best Annual Reports Awards 2024, the Gold Award for Most Sustainable Companies at the Best Corporate Governance and ESG Awards 2024, as well as the ESG Leading Enterprise and Leading Environmental Initiative at the Bloomberg China ESG Leading Enterprises 2024.

Developed by **Swire Properties**, Taikoo Hui Guangzhou (Tower 2) – HSBC Office reached a major sustainability achievement, obtaining two Leadership in Energy and Environmental Design ("LEED") Zero certifications. It is the second and largest mixed-use office project globally in terms of office building gross floor area, and the first mixed-use Chinese Mainland office building project to achieve both LEED Zero Carbon and LEED Zero Energy certifications, a shining example of how Swire Properties' pioneering approach to landlord-tenant partnerships can bring positive change for the environment. The company was recently officially recognised during a small get-together with its tenant-partner and fellow BEC Member HSBC and representatives from a non-profit organisation of the U.S.

Towngas set up an ESG consultancy company in 2024 to tap into the growing demand for ESG consultancy services. It offers one-stop ESG solutions, including climate strategy development, reporting and disclosure support, technical training, among others. To promote low-carbon travel, the company has recently collaborated with a travel agency to launch the first-ever ESG training programme for travel guides in Hong Kong. The programme is designed to foster sustainable travel and lifestyle habits by leveraging the influential role of travel guides. Through specialised training, travel guides will encourage eco-friendly choices among travellers, helping to reduce carbon footprints and promote sustainable tourism.



Wheelock Properties recently took part in an ESG Forum, sharing insights about its ESG journey and exchanging ideas with key industry leaders. Mr Ricky Wong, MH, Vice Chairman and Managing Director of Wheelock Properties, highlighted the company's commitment to sustainability through green building developments, collaborations with NGOs and social enterprises, and a transitional housing project in partnership with the Housing Bureau and a non-profit organisation. He also shared about "Project WeCan", an initiative focusing on empowering youth which showcased Wheelock's role in shaping the future generations. These efforts exemplify a vision of fostering a diverse, inclusive, and sustainable society while creating long-term value for the community.

As part of **AECOM**'s commitment to fostering a nature positive city, it has partnered with the Civil Engineering and Development Department and the Agriculture, Fisheries and Conservation Department of the Hong Kong SAR Government, to conduct an investigation study for the Sam Po Shue Wetland Conservation Park. This 348-hectare park, the first initiative under the Northern Metropolis Development Strategy, aims to rejuvenate valuable wetlands, boost biodiversity, provide eco-education and eco-recreational opportunities, and support sustainable aquaculture. The company's efforts include preliminary design, engineering infrastructure, wetland enhancement, landscaping, environmental sustainability, digital monitoring, and park management.

Chun Wo Development Holdings Limited ("Chun Wo") highlights its sustainability commitment through the Sau Nga Road Stormwater Storage Scheme, featuring an innovative Solar Panel System. The system powers water heaters in public restrooms and all electricity facilities in workers' rest zones, seamlessly integrating with existing setups without costly replacements. By converting sunlight into energy, it reduces electricity costs and fossil fuel reliance while minimising greenhouse gas emissions, contributing to climate change mitigation. By harnessing renewable solar energy, Chun Wo sets a benchmark for sustainable development while benefiting both the community and the environment.



DynaSys' intelligent recycling management system, Greenbird, has been implemented by a local commercial complex to automate data collection on solid waste and recyclable materials like paper, plastic, and metal from its commercial buildings. This serves as an example for property management companies to address upcoming waste disposal charges while meeting ESG reporting requirements for both the corporation and its tenants.

Hong Kong Disneyland Resort ("HKDL") recently inaugurated Hong Kong's first and largest car park solar canopy, which is being installed in the car park for its cast members. The bi-facial solar panels generate electricity from both sides, increasing energy generation by nearly 10% compared to traditional single-sided panels. Upon completion of the second phase, the entire car park will contain approximately 400 bi-facial solar panels generating more than 200,000 kWh of electricity annually and providing shelter for 80 parking spaces. This initiative is part of HKDL's continued efforts in conservation and renewable energy adoption, reinforcing its leading position in sustainable energy and pioneering environmental initiatives in Hong Kong.



MTR has been included in S&P Global's Sustainability Yearbook 2025 for the sixth consecutive year, underscoring the company's outstanding sustainability performance. Ranking within the top 15% of its industry globally, this achievement is a testament to the company's unwavering commitment to Keeping Cities Moving and fostering growth alongside the communities it serves.
