## OUTLOOK FOR 2022 AND 30 YEARS OF ENVIRONMENTAL EXCELLENCE

**Mr Simon Ng shares his first words as BEC's Chief Executive Officer after assuming the post on 3 January.**



As BEC's new CEO and in the first issue of our 2022 e-Newsletter series, I want to start by wishing you all a healthy and happy New Year!

If you care about the environment, 2021 is a year to remember for mixed reasons. On the impact of climate change, we witnessed countless extreme weather incidents from heavy rains, intensified storms and deadly floods to ferocious wildfires and searing heat waves in different parts of the world, on a much more regular basis and causing greater damage and casualties. It was also confirmed in the Sixth Assessment Report ("AR6") of the Intergovernmental Panel on Climate Change ("IPCC") published last August that greenhouse gas emissions from human activities are accountable for approximately 1.1°C of warming since the pre-industrial period, and the window to keep 1.5°C within reach and avoid catastrophic and irreversible implications on mankind and the ecosystem is closing fast.

Equally worrying is the global biodiversity loss driven largely by human activities, with one million species now threatened by extinction. The Biodiversity Integrity Index, an indicator which represents the proportion of the original number of species in an area that remain and their abundance, is showing a downward trend and measured at about 75% globally in 2020, falling below the safe limit of 90%. Biodiversity loss will damage ecosystem services, endanger food security, compromise human health and threaten economic output, to say the least.

Incidentally, "climate action failure", "extreme weather" and "biodiversity loss" have been identified by the *Global Risks Report 2022* as the top three most severe risks on a global

scale over the next 10 years.

On the plus side, COP26 was concluded with the Glasgow Climate Pact, demanding countries and political leaders to set more ambitious carbon reduction targets and commit to deeper cut in greenhouse gas emissions when they meet again this year during COP27 in Sharm El-Sheikh, Egypt. Besides, the first part of the Fifteenth Meeting of the Conference of the Parties to the Convention on Biological Diversity ("CBD COP15") was successfully held in Kunming, China, agreeing on the post-2020 Global Biodiversity Framework and gaining support from 195 countries and the European Union to protect and conserve 30% of land and sea areas by 2030. The second part of CBD COP15 will reconvene this April/May in Kunming to finalise and adopt the post-2020 Global Biodiversity Framework.

Another promising sign noticeable in 2021 and will hopefully continue this year is that more and more global brands and business leaders are stepping forward and committing to ambitious carbon reduction targets. For example, the number of companies committed to Science Based Targets initiative has risen from a few hundreds to over 2,000 since 2019. Over 950 companies representing market capitalisation of more than US\$13 trillion have signed the Business Ambition for 1.5°C and set science-based targets. On reversing nature loss, more than 1,000 companies with revenues of US\$4.7 trillion have signed the Business for Nature's Call to Action, calling on governments to adopt policies and take collective actions to ensure that biodiversity is on a recovery pathway within the next decade.

Back in Hong Kong, BEC is excited by the publication of four policy blueprints in 2021 – *Waste Blueprint for Hong Kong 2035*, *Hong Kong Roadmap on Popularisation of Electric Vehicles*, *Clean Air Plan for Hong Kong 2035*, and *Hong Kong's Climate Action Plan 2050*. These important documents are

warmly welcomed by the business community, as they set out clear policy direction on major environmental issues in the coming decades, paving ways for corporate action and business investment to facilitate the transition towards a future-proof, climate-resilient, green and sustainable future.

Finally, there is the small thing of BEC celebrating our 30th anniversary this year.

We were originally formed by 19 leading businesses under the name of the Private Sector Committee on the



### Council Members

**Airport Authority Hong Kong ("AAHK")** published its first Task Force on Climate-related Financial Disclosures ("TCFD") Statement in its Sustainability Report 2020/21 to communicate its material climate-related risks and opportunities, and provide confidence to investors on AAHK's resilience to climate change. To address TCFD recommendations, AAHK completed two studies in climate adaptation and climate mitigation. The Climate Resilience Study reviewed and strengthened Hong Kong International Airport's operational resilience and adaptive capacity to a changing climate while the Long-term Carbon Target Study determined a new airport-wide target of achieving net-zero carbon by 2050, with a midpoint target for 2035.

This renewable energy procurement will take the company's own usage of renewable electricity in its Mainland developments to over 14%, marking a significant milestone of its 2030 Sustainability Goals and Targets, reaffirming its commitment to net-zero.

As of end of 2021, green financing constitutes about 30% of the company's current bond and loan facilities. 100% of the net proceeds from its 5 green bonds have been fully allocated to eligible green projects, including green buildings (HK\$5,600 million), energy efficiency (HK\$183 million), renewable energy (HK\$17 million) and sustainable water and wastewater management (HK\$12 million). The company has recently issued the Green Finance Report 2021 to report on the quantitative environmental impacts including carbon and energy reduction, water savings and renewable energy generation.

**Baguio Green Group** will set up a 35,000-square-feet Chicken Farm Waste Treatment Plant at EcoPark to take in 10 tonnes of chicken manure and output 5 tonnes of organic products daily, including 1.5 tonnes of mature larvae as animal feed and 3.5 tonnes of insect frass as organic fertiliser. The facility is expected to begin operations in September 2022. It is estimated to take up one-third of organic waste from Hong Kong's chicken farms.

In August, the Securities and Future Commission ("SFC") issued Consultation Conclusions on the Management and Disclosure of Climate-related Risks by Fund Managers, setting out requirements for fund managers to take climate-related risks into considerations. In the report, SFC recommended fund managers to make reference to the PCAF Standard, which provides guidance on methods to estimate and calculate the GHG emissions of various asset classes. Given the complexity and breadth of PCAF Standards, **GreenCo ESG Advisory Limited** summarised the key takeaways of the report, articulating the requirements and methodologies in a clearer manner to intended users.

In the webinar, the highly performative and sustainable nature of cork was introduced, with case studies presented to recognise the value of adopting cork into businesses, in line with the trend of escalating noise and vibration levels in cities and net-zero carbon goals. One key application of cork panel in an indoor environment is to reduce reverberation enhancing the speech intelligibility.



SSID founded Hong Kong’s first pulp mill, Mil Mill, and an education centre that recycle beverage cartons since 2019, aiming to process cartons and composite-paper products that are difficult to recycle, producing recycled pulp for re-use. The company also launched the “Community Beverage Cartons Recycling Network” to collect beverage cartons, helping citizens with waste reduction and proper recycling, ultimately reducing negative impacts to the environment.



**The Harbour School (“THS”)** has launched the Meatless Monday Campaign to encourage all stakeholders to pledge for a green diet and contribute to sustainability. In particular, THS invited food companies to interact with the international students and community and demonstrate how plant-based food could become a driving force for sustainable development. THS strongly believes education about sustainable development to the younger generation is key to achieving Hong Kong’s Climate Action Plan 2050.
