### Response to 2019 Policy Address



BEC welcomes the Government’s new pilot scheme that subsidises qualified private residential buildings to install electric vehicle charging-enabling facilities as a practical means to support EV users in terms of charging. However, it is equally important to promote and accelerate the transition to electric commercial vehicles in Hong Kong and to support the provision of charging points in locations convenient to their operation. BEC also commends the Government’s plan to replace entire fleets of the 11 ferry routes with green ferries starting from 2021, which will contribute to further local air pollution reduction and decarbonisation of the transport sector.

## Submission on Air Quality Objectives Review



Clear air is important for the well-being of Hong Kong people. In our submission, we support the Government’s proposal to tighten Hong Kong’s Air Quality Objectives. The Government should draw up “A Clean Air Plan for Hong Kong 2.0” as soon as possible to develop new air quality management strategies with implementation plan and clear timeline. It should include an integrated approach to tackle traffic congestion and roadside air pollution, a pilot scheme to trial the use of electric ferries to reduce air pollutant emissions from the marine transport sector, etc. BEC also recommends the Government to provide real-time roadside air quality data to inform people’s travel decisions as part of the smart city initiative.

BEC Council Member **Swire Properties** has once again attained exceptional results, with the company taking leadership positions in three of the world's most recognised sustainability indices. For the third year in a row, Swire Properties was the only constituent company from Hong Kong and Mainland China to be listed in the Dow Jones Sustainability World Index (DJSI World). The company was ranked 8th this year out of 23 top-tier real estate developers in the world and was No. 1 in Asia. Swire Properties has again taken a leading position in this year's Global Real Estate Sustainability Benchmark ("GRESB"), retaining the global's No.1 spot in the Other (mixed-use development) category, progressing to Asia's No.1 for all property types, and maintaining a 5-star rating, the highest possible score, for the third year in a row. In Hong Kong, Swire Properties topped the Hang Seng Corporate Sustainability Index 2019, receiving the highest total score among all index constituents, and maintaining "AAA" sustainability rating, the highest possible grading.

With rising concerns about climate change, Meiyume, one of the business units under BEC Corporate Member **Fung Group**, has recently announced its sustainability strategy - Empowering Sustainable Beauty Solutions. Among others, one of its goals is to eliminate all virgin fossil-fuel-based plastics from production by 2025. Meiyume is testing alternative materials such as post-consumer recycled plastic and bioplastics. This push in environmental awareness further aligns with the UN Sustainable Development Goal for Responsible Consumption and Production. "We cannot wait for our customers to push us, we must be proactive in providing the solutions to them," stated Gerard Raymond, President of Meiyume. It has been actively collaborating with supply chain partners and customers to develop packaging using recycled material. A project in the pipeline is a lipstick packaging using 70% recycled plastic. Meiyume is working towards creating product solutions using 100% recycled material in the next five years. It will help drive the circular economy and give its customers a better avenue to connect with the values of their end-consumers.


