ReThink HK 2024







BEC was glad to be the exclusive co-organiser of ReThink HK for four consecutive years. The 2024 edition of the event wrapped up with great success on 12-13 September at the Hong Kong Convention and Exhibition Centre.

During the two-day event, BEC hosted a dedicated BEC Business Transformation Theatre, covering topics on "Embracing Circularity for Sustainable Living". The programme on Day 1 focused on "Business-Policy Nexus for Circularity and Sustainable Living", exploring the current sustainability challenges in Hong Kong, the latest circular technologies and practical eco-designs for combatting such challenges, as well as ways to strengthen the repair and reuse economy.

Moving on to "Rethinking Communities", our programme on Day 2 looked to the roles of non-profit organisations, public agencies, residents and SMEs. The emergence of innovative cross-sector collaborations through public-private-people partnerships and the potential of sustainable SME business models were highlighted.

The BEC Pavilion also showcased the latest sustainable technologies and solutions of BEC Members, accelerating sustainable development and contributing to the transition to a net-zero economy. The event brought together invaluable insights and innovative solutions in achieving carbon neutrality.



The seminar highlighted the close relationship between the property and facilities management industry and the construction industry. We look forward to fostering communication and collaboration between sectors, bringing the enthusiasm and momentum to create a green and sustainable future.

BEC Technical Visit - Unveiling Technological Advancements and Sustainable Elements in Cement Production

BEC successfully held its technical visit "Unveiling Technological Advancements and Sustainable Elements in Cement Production" for our members on 30 August. Representatives from Green Island Cement led an eye-opening tour to the state-of-the-art cement plant, where innovation meets environmental responsibility. They also introduced to the group the precision of raw material handling and blending procedures, not to mention the plant's rigorous testing procedures and the Ground Granulated Blast Furnace Slag grinding facility.



As a highlight of the visit, Director Mr KK Choi specially introduced how the raw meal undergoes a series of concurrent heat exchanges in the preheater with the hot exhaust gas from the rotary kiln. The material temperature rises to as high as 1,450°C, at which a semi-product of cement, called "clinker", is formed. Mr Choi added that it was the first time for visitors to see the inside of the kiln and the low-NOx kiln burner design.

Practising ESG in Event Organisation

As we reflect on the success of BEC Anniversary Dinner 2024, it is the perfect opportunity to discuss the importance of ESG practices in organising events. In today's world, where sustainability is at the forefront of many dialogues, integrating ESG principles into event planning is not just a trend, but a necessity.

For environmental considerations, the focus is on minimising the ecological footprint of events. This includes considerations such as waste management, energy consumption, and sourcing materials sustainably.

Implementing a waste management plan is crucial. Some simple ways include encouraging digital invitations, programmes, and menus to reduce paper waste, providing clearly marked recycling bins, partnering with hotels, restaurants, or caterers to minimise food waste and donate leftovers to local charities.

Sustainable sourcing is another good way to practice ESG. A lot of event organisers prefer selecting local vendors and suppliers who prioritise sustainable practices. This not only supports the local economy but also reduces transportation emissions. Using decorations and materials made from recycled or biodegradable products is another good practice.

In addition, carbon offsetting has become a common practice today. Event organisers should consider purchasing carbon offsets after calculating the carbon footprint of their events to achieve carbon neutrality. As a leader in environmental excellence promoting net-zero action, BEC is committed to ensuring that all our events are carbon neutral.

The social aspect of ESG pertains to how an event impacts its stakeholders and the community at large. Fostering inclusivity and supporting social causes should be at the heart of event planning.

First of all, event organisers should ensure the events are accessible to all. This includes physical access for individuals with disabilities, as well as considering diverse dietary needs. Providing materials in multiple languages can also enhance inclusivity.

Engaging with the local community by showcasing local artists, musicians, or speakers is also another way to enhance social values of events by strengthening community ties. Additionally, event organisers may consider partnering with local charities or organisations, allowing quests to contribute to a cause that resonates with them.

The governance component of ESG encompasses transparency and accountability. By being transparent about the sustainability efforts and communicating ESG goals and practices to all stakeholders, including attendees, sponsors, and partners, trust and collaboration can be enhanced. Building relationships with vendors and partners who share a strong commitment to ESG principles may involve

conducting due diligence to ensure their practices align with sustainability and ESG values. Gathering post-event feedback regarding ESG practices can also provide valuable insights for future events and demonstrate a commitment to continuous improvement.

Here are some tips for implementing ESG practices in event organisation. If your organisation is new to ESG practices, begin with small changes. This could be as simple as reducing single-use plastics or choosing a local caterer. Please be bold to set clear targets by defining specific, measurable ESG goals for your event. This could include reducing waste by a certain percentage or sourcing a specific amount of local produce. It is also essential to educate your team to ensure that everyone involved in the planning process understands the importance of ESG practices. Providing training or resources to help them implement these principles effectively is critical. Moreover, do not forget to promote your efforts and let others know about them. Do not be shy to use social media and other communication channels to share your ESG initiatives before, during, and after the event by highlighting the positive impact of attendees' participation.

In conclusion, by embracing ESG practices in event planning, we can create gatherings that are not only memorable but also responsible and impactful. As we move forward, let us commit to making sustainability a fundamental aspect of every event we organise, fostering a culture of responsibility and care for our planet and its people. Together, we can lead the way in demonstrating that events can be a force for good.

The Airport Authority Hong Kong ("AAHK")'s two aviation fuel facilities have obtained International Sustainability and Carbon Certification: Carbon Offsetting and Reduction Scheme for International Aviation ("ISCC CORSIA"). This certifies that the sustainable aviation fuel ("SAF") handled at these facilities complies with ICAO's CORSIA sustainability requirements and enables traceability throughout the SAF supply chain. By providing fuelling infrastructure for SAF, AAHK enables airlines to efficiently receive, store, and utilise pre-blended SAF, significantly contributing to the decarbonisation of airline operations and reducing Scope 3 emissions. AAHK remains committed to promoting SAF uptake in Hong Kong.



CLP Power Hong Kong Limited ("CLP Power") and a major public housing property management service provider in Hong Kong signed a Memorandum of Understanding ("MoU") on 8 August. The MoU aims to strengthen the capability of the partner's property management team in energy management and handling of power incidents, improving the industry's resilience to cope with extreme weather conditions. The partnership will also help the partner enrich its residents' knowledge of energy saving and decarbonisation and promote the use of digital customer services to mitigate the impact of climate change in the long run.

Since April this year, residents have been moving in gradually. This project comprises 1,236 residential units and is expected to benefit approximately 10,000 residents over its eight-year lifespan. This is the first project to reuse existing MiC components and ecological assessments are conducted to minimise environmental impact. Additionally, re-energising the community is another key focus of this project. ATAL won the "Sustainable Organisation – Gold Award" at the UNSDG Achievement Awards Hong Kong 2024, which recognises organisations that align their business practices and sustainable operations with the United Nations Sustainable Development Goals. ATAL is dedicated to developing innovative construction technologies to assure quality, safety and efficiency, while investing in artificial intelligence, Digital Twin and robotic solutions as well as environmental technologies for climate solutions, clean water and waste treatment to meet customer needs and create value for the community.



In September, **HAECO** became the first company to conduct an electric ground power unit ("eGPU") trial at the Hong Kong International Airport, setting a new milestone in the company's sustainable development goals. Among the wide range of vehicles used in its operations, eGPUs are crucial in supporting maintenance services as they supply stable electricity to an aircraft. In the latest try-out on an Airbus A350, the eGPU facilitated a successful deep clean service by providing stable electricity output. During the six-month trial project, the eGPU is expected to contribute a carbon reduction of 78.9% compared to its diesel counterpart. As HAECO continues to move forward with its extensive fleet electrification plan, it is eager to explore new opportunities and be a positive force in driving a sustainable future.

Arup has been appointed to lead a joint venture with fellow BEC Member AtkinsRéalis on the investigation consultancy works of Lau Fau Shan, Tsim Bei Tsui, and Pak Nai Areas ("LFS"), following its successful delivery of the Land-use Review Study for the same area. LFS is a key component of the High-end Professional Services and Logistics Hub in Northern Metropolis. Arup will adopt its Smart Green Resilient approach, Nature-based Solutions and beyond to empower LFS with greater biodiversity and enhanced connectivity, unlocking its value in becoming a "New Digi Bay" and a future eco-tourism exemplar.

AS Watson's flagship health and beauty brand collaborated with a non-profit organisation to launch the Medicines Disposal Programme in Hong Kong in June. Medicine collection boxes for unused or expired medicines were placed in nearly 60 Watsons pharmacies across all 18 districts of Hong Kong. Over 7.2 million pills were collected, a fourfold increase from last year. More than 600,000 MoneyBack points were distributed to encourage customer participation. The programme prevented chemicals from entering soil or water sources, protecting human health and the environment while raising public awareness about responsible medication waste disposal.

As solar panel installations continue to increase and factors such as extreme weather, safety concerns, and technological advancements often lead to premature disposal, solar panels are ending up in landfills and polluting the sea at an alarming accelerating rate. With this concern in mind, **Circular Economy (Hong Kong) Limited** teams up with a regional association to develop a circular solar waste management platform that connects solar supply chain stakeholders with an initiative to boost the circular economy by providing cost savings and opportunities for resource recovery and achieve low carbon emissions targets.


