María Mendiluce has over 20 years' experience in sustainable development, energy and climate action. In addition to sitting in the Senior Management Team of the [World Business Council for Sustainable Development](#) (WBCSD), where she guides over 200 member companies on transformative climate policy and energy transition, María formally adopted the role of CEO of the [We Mean Business](#) coalition in May 2020. Her prior work experience includes roles at the Economic Bureau of the Spanish Prime Minister, the CEO office of Iberdrola, and the International Energy Agency (Paris). María has a PhD in energy economics and regularly teaches at different universities and publishes in academic journals and media.



Prof Christine Loh, SBS, JP, OBE

Chief Development Strategist, Institute for the Environment

Hong Kong University of Science and Technology

Professor Christine Loh, SBS, JP, OBE, Chevalier de l'Ordre National du Mérite, is Chief Development Strategist, Institute for the Environment, at the Hong Kong University of Science and Technology. She was Under Secretary for the Environment in the HKSAR Government (2012-17) and a Member of the Hong Kong Legislative Council (1992-97 and 1998-2000). Loh has been active in public policy and politics since the 1980s. She founded and was the CEO of the non-profit think tank, Civic Exchange (2000-12), and helped to establish several non-profit and philanthropic organisations.

Professor Loh teaches a course on non-market risks at UCLA's Anderson School of Management during the winter quarter and is a board member of the Robert HN Ho Family Foundation, CDP Worldwide, and Global Maritime Forum. She is also a member of BASF's Stakeholder Advisory Council, as well as HSBC's Climate Advisory Panel. Loh is a published author of many books and academic and popular works. Her expertise in environmental policy is well-known, including having advised the World Health Organization and International Energy Agency on issues relating to air pollution and public health. Loh is a lawyer by training, and a commodities trader by profession. She received her legal training in England and received honorary degrees of Doctor of Law from the University of Hull and Doctor of Science from the University of Exeter.



Mr Mike Kilburn

Mr Mike Kilburn is the Assistant General Manager, Sustainability for Airport Authority Hong Kong (“AAHK”). He is responsible for developing and implementing AAHK’s “greenest airport” pledge, through its industry-leading “airport-wide” approach to managing Hong Kong International Airport (HKIA)’s environmental footprint. He is also responsible for evolving AAHK’s sustainability strategy and sustainability reporting process.

Mr Kilburn is Chair of the Airports Council International (ACI) World Environment Standing Committee, former Chair of the ACI Asia-Pacific Regional Environment Committee and Chair of the Hong Kong General Chamber’s Environment and Sustainability Committee.

Prior to joining AAHK in 2012, he worked for public policy think tank Civic Exchange, where he developed and engineered the implementation of policy-level solutions on air quality and public health, biodiversity, and land use planning. He is Vice Chair of the Hong Kong Bird Watching Society and a founding Director of the Hong Kong Countryside Foundation.

Since July 1st, 2019 Dr. Christian Hübner is the Director of the Regional Programme Energy Security and Climate Change in Asia-Pacific of the Konrad-Adenauer Foundation (KAS) based in Hong Kong SAR/PR China. Before, he has been the Head of the Regional Programme Energy Security and Climate Change in Latin America of the Konrad-Adenauer Foundation (KAS) based in Lima, Peru. Prior to this position he has worked as Coordinator for environmental, climate and energy policy within the KAS department of European and International Cooperation in Berlin. His thematic priorities are energy transition policy, geopolitics of energy security, economic evaluation of climate policy instruments and Blockchain-Technology. The three years before joining the foundation Christian Hübner has been research associate at a research institute of the Leibniz Association. There, as a trained economist, his focus has been on environmental economic analysis of ecosystems.

Dr Raymond Yau

Dr Raymond Yau is the General Manager, Technical Services & Sustainable Development in Swire Properties Limited. Under his leadership since 2016, he leads a number of new initiatives that are pivotal to the long-term sustainable development of the company. These include formulation of company's wide SD 2030 Vision and strategies, digital transformation of technical services and cloud-based energy management platform, implementation of monitoring-based commissioning of all existing portfolios for deep energy savings, ESG framework of the company's first green bond of US\$500m in 2018 and the Climate Risk Assessment of its global assets. Dr Yau led to set out the Science-based Targets of Swire Properties for long-term decarbonization in accordance with The Paris Agreement and climate science that was officially approved by SBTi in November 2019.

Dr Yau had been practicing as a professional consulting engineer for over 28 years in the field of designing sustainable buildings and sustainability consulting across the Globe. He was awarded HKIE - Innovation Award for the Engineering Industry 2013 – Principal Innovator - Construction Category Champion CIC Zero Carbon Building.

He is also Committee Member of the China Green Building Council and Deputy Officer of China Association of Building Energy Efficiency – Technical Committee on Building Commissioning and Operation.

Dr Yau is Guest Professor at Chongqing University, China and LEED AP, WELL AP, Green Building Faculty, BEAM Pro, Chartered Engineer and Fellow Member of HKIE and CIBSE. Dr Yau received the 2019 International WELL Building Institute (IWBI) Leadership Award.
