The Untold Story of BEC Building


Business Environment Council (“BEC”) is headquartered in the iconic BEC Building. The first time you step in the BEC building, it’s cosy, welcoming and contemporary. Let’s take this exclusive opportunity to unwind some key historical materials and discover BEC’s sustainability journey since the early history of its building. BEC Building, formally known as Jockey Club Environmental Building (“JCEB”), is a distinctive icon of BEC. The cylindrical building, inspired by the traditional Hakka Tulou, has been standing in the tranquil district since 1996, but little is known about the early days of this precious asset of BEC.

The planning stage of JCEB can be traced back to 1993, when the Centre for Environmental Technology (predecessor of BEC) received the concept sketches, floor plans and section drawings of the proposed building from the architect.

According to an SCMP article in June 1995, JCEB is a building “dedicated to increasing awareness among business and industry of the importance, necessity and benefits of environmental management.” It is literally the first building of its kind in Hong Kong where environmental considerations were applied as principal factor in design, construction and operation. For instance, hardwood was not used for the site hoarding and the composite hoarding panel alternatives were subsequently re-used as office partitions. In terms of design, an exterior done in earth tone would blend the building perfectly with neighbourhood. Parking lots at the building were also minimised to encourage visitors to make use of public transport when visiting the building.

On 11 September 1996, JCEB was officially opened by then Chief Secretary of Hong Kong Mrs Anson Chan. The commemorative plaque at the opening ceremony is now placed at the building entrance.





In 1997, JCEB won the Certificate of Merit at the prestigious Hong Kong Institute of Architects (“HKIA”) Annual Awards, being one of the only two awardees that year. This recognition subtly conveyed that Hong Kong should be “more concerned with environmental issues in order that we can work gradually towards sustainable development,” as indicated by distinguished architect, then HKIA President Dr Tao Ho.

Driven by the fame and accolade our building enjoyed at its early stage of opening, BEC continuously upholds its vision and efforts to enhance its environmental performance. For decades, we have introduced and experimented various state-of-the-art green technologies to the building, transforming to a “Green Lab”.

In 2014, BEC Building achieved the Platinum rating of Provisional Assessment under the BEAM Plus Existing Buildings (version 1.2), and became the first commercial building in Hong Kong meeting the highest level of recognition. The building subsequently attained the Platinum rating of Final Assessment in 2017. The roof-top solar panel installation in 2018 and extensive renovation of the Auditorium and Exhibition Hall in 2019 have further lifted BEC Building’s environmental performance. Looking forward, BEC will continue to advocate a green, healthy living environment and set a robust example of green buildings in Hong Kong through our “Green Lab”.

For three decades, BEC has been at the forefront of promoting environmental excellence by advocating the uptake of clean technologies and practices which reduce waste, conserve resources, prevent pollution and improve corporate environmental and social sustainability. Our “Green Lab” showcases how we apply and support environmental solutions in life.

Experienced and skilled staff is instrumental to Business Environment Council's ("BEC") success. We highly value positive interaction between colleagues as senior staff is seen more than just a supervisor, but a mentor to the junior as well. As we celebrate our 30th anniversary, we talk to two of the longest-serving employees of BEC, who happen to be our senior management team members. Mr Ivan Chan, Director - Finance, has been serving BEC for 20 years, while Ir C.F. Leung, Director - Operations, has been with us for 15 years.

Joining BEC in 2002, Ivan is a credible witness to BEC's growth and development in the past two decades. He had never worked in the environmental or sustainability field before joining us, but he stayed on to serve the organisation for 20 years. "Back then, some citizens had a rather negative perception on NGOs, criticising the ineffectiveness of some," recalled Ivan. "BEC is different though. We are determined to address pressing environmental issues by adopting a four-pronged approach – advisory, research, stakeholder engagement, and training. I think our contributions to the Hong Kong community are evident. My 20 years of service here can prove a point."

One common misconception about BEC is that the organisation is funded by the HKSAR Government. "No, BEC is an independent organisation. We receive no funding from the Government," clarified Ivan. "It is therefore essential for me and my team to keep BEC's expenditure within the limits of revenues when drawing up our budget."



In his two decades of tenure at BEC, Ivan has gone through two major outbreaks – SARS in 2003 and the ongoing COVID-19. Has he noted any differences on BEC? "Not really, to be honest. Because BEC has always attached utmost importance to our colleagues' health and well-being," said Ivan. "The SARS outbreak was more lethal but didn't last long. In contrast, the COVID-19 pandemic has more far-reaching effects on various aspects of our lives. In terms of financial planning, I have to channel more resources to support BEC's initiatives in maintaining our staff's physical and mental health during this unprecedented pandemic." Thanks to Ivan and his team's effort, BEC has maintained a decent financial situation despite the pandemic, managing to avoid any wage freeze or cuts. A number of initiatives and events have also been launched to enhance our staff well-being during this challenging period.

Joining BEC as a Specialist in Built Environment in 2007, C.F. has climbed up the career ladder over the years and is now our Director – Operations, leading and providing advisory services on various BEC's initiatives. He oversees BEC's Green Building, EHS Performance Testing, Environmental Management, and Community Engagement teams. "Leading four teams is no easy task. In fact, BEC has grown a lot in terms of number of staff. We had less than 20 when I joined, but now over 50 of us are working here," said C.F.

As a green building expert, C.F. led the renovation project of BEC's Exhibition Hall and Auditorium in 2019. The project has met with popular acclaim from BEC's members, partners and every visitor to the Building. "This is one of my finest achievements at BEC," said C.F. proudly. "Introducing various green elements to the venues was challenging yet meaningful." After renovation, the venues are now infused with green features such as a LED screen, bamboo stage, cork walls, a BEC logo decorated with reused plastic bottles, carpeting made from recycled materials, eco-friendly ventilation and natural lighting.



People are starting to attach the utmost importance on health and well-being. In this aspect, C.F. said, "On average we are spending as much as 90% of our time indoors. Thus, a building with good indoor environmental quality is essential to safeguard the health and well-being of the occupants." In early 2022, BEC was accredited as a WELL Performance Testing Organisation, becoming the first Hong Kong-based NGO to offer this service. BEC can now provide independent third-party performance verification services for projects pursuing WELL v2 certification.

"I hope BEC can continue to lead by example and demonstrate the latest green practices to the business sector," said C.F. In fact, BEC Building has achieved the WELL Health-Safety Rating, an evidence-based, third-party verified rating focusing on operational policies, maintenance protocols, stakeholder engagement and emergency plans to address a post-COVID-19 environment now and into the future.




