

The Financial Secretary will deliver his Budget Speech for the coming fiscal year on 28 February 2018, and is currently accepting views from the public.

BEC has recently made a submission for the Budget highlighting key aspects of our earlier Policy Submission in October 2017, and our Roadside Emissions Taskforce Report 2016, which we believe can be taken forward without delay. We have also affirmed our earlier recommendations.

The policy recommendations we have highlighted for this year's budget are summarized below.

1. Support the 4Ts Climate Change Charter and business target-setting

Ensure sufficient funding to enable expert advice to be obtained for setting robust and evidence-based carbon reduction targets

2. Support the transition to low emission transport & logistics

Continue and extend the scope of the ex-gratia payment scheme to encourage the purchase of Euro VI, hybrid and electric commercial vehicles and buses, as well as incentivise cleaner ferries and river boats

Commit funds to a comprehensive EV charging infrastructure, in particular at transport hubs, in existing residential buildings, and for new infrastructural developments

Review the First Registration Tax (FRT) as well as other road taxes/incentives for private vehicles and taxis to take on board congestion and pollution considerations 3. Improve energy efficiency of commercial buildings

To help address the split incentive problem, establish a fund to support pilot schemes for installation of meters in tenanted commercial premises

To address the risk-related barrier for investments in buildings energy efficiency, support expert Energy Service Companies (ESCOs) through loan guarantees

4. Incentivise waste collection and recycling

Simplification of the rules of the Recycling Fund, for example, enable funds to be used to meet operational costs as well as capital costs

- Provide funding:
 to help the recycling industry and/or other businesses in the value chain pay for the space needed to collect, store and separate out waste
- for pilots to trial new approaches to different aspects of waste management; and
- for a comprehensive circular economy study to examine the potential for closed loop systems in Hong Kong or in conjunction with the wider region
